POINTS TO BE CONSIDERED FOR TECHNICAL QUALIFICATION:-

1. D.D of EMD, processing fee & Tender fee must be submitted in time without which tender form will not be accepted.
2. Tenderers having any case pending against Sriganaganagar Milk Union or its officers/ employees (pertaining to working of Dairy) will not be accepted.
3. Tenderers having any case against them by Sriganaganagar Milk Union shall be rejected.
4. Rates are to be quoted only in prescribed BOQ format.
5. Tenderers who have been blacklisted/ termination of agreement in past by SGZDUSS or any other RCDF milk union shall not be considered for this tender.
6. Tenderers having any financial dealing with any of the employees of milk union as on date of submission of tender shall not be considered
7. Tenders of any of the officer/ employee/ board member of SGZDUSS Ltd or their blood Relatives (as per Hindu family act) will not be accepted.
8. Tenders of any insolvent/ adolescent/ mentally retarded firm/ person will not be accepted. Tenders of any person/ firm working in same / similar Competitive business will not be accepted.
9. The tenderer should be qualified at least ITI/ BSC / B.tech & having minimum two years experience of operation and maintenance of minimum 500 KLD capacity effluent treatment plant in a cooperative Dairy. Other wise tender form will be rejected.
10. Signed photocopies of registration certificates under ESI, PF, GST no., PAN no., Aadhar, experience certificate/work orders and Income Tax Return (2021-22 and 2022-23) needs to be enclosed in tender form. Other wise tender form will be rejected.
11. Submit acceptance of tender document and specifications in the enclosed format.
12. The successful tenderer will be one who fully agrees to comply with all the terms and conditions of this tender documents without any omission, deviation and reservation and possesses the required qualifications and experience and whose financial bid is evaluated as the lowest by Sri Ganganagar Zila Dugdh Utpadak Sahakari Sangh Limited, Hanumangarh.



TERMS & CONDITIONS (GENERAL)

1. The tenderer should be qualified at least ITI/ BSC / B.tech & having minimum two years experience of operation and maintenance of minimum 500 KLD capacity effluent treatment plant in a cooperative Dairy. Other wise tender form will be rejected.
2. Photocopy of registration certificates under ESI, PF, GST no., Pan no. to be enclosed in tender form. Other wise tender form will be rejected.
3. The right to negotiate & / or to cancel the tender without assigning any reason lies with Managing Director, SGZDUSS.
4. In case of any dispute, the decision of Arbitrator would be final and binding on all concerned parties. Chairman of SGZDUSS is sole arbitrator.
5. In case it is felt that the quoted rate is on higher side, the SGZDUSS reserves the right to negotiate the rates with the bidders. The right to take the final decision would lie with the SGZDUSS.
6. The Tender may be cancelled without assigning any reason by the Managing Director, SGZDUSS. The decision of Managing Director, SGZDUSS would be final and binding in all the cases.
7. The successful bidder will deposit Rs. 1,50,000/- (One lakh Fifty Thousand Only) as security deposit. The EMD deposited by the successful bidder will be included in security and difference amount have to be deposited by contractor for the period of contract . The security amount would be refunded to the party after expiry of contract on production of " No Dues" certificate. No interest would be payable on the security amount.
8. The security amount would be forfeited in the event of breaking the contract before the contract period by the tenderer.
9. Before assuming work, an agreement related with **TERMS & CONDITIONS (TECHNICAL)** of this NIT shall be executed by tenderer on Rs. 500/- Nonjudicial Stamp Paper with SGZDUSS.
10. Conditional tender documents will not be acceptable.
11. Over- writing on quotation / tender shall not be allowed.

TERMS & CONDITIONS (TECHNICAL)

- 1- The tenderer has to operate the ETP for 24hrs in all the three shift with the help of his trained persons under his direct supervision. Operation area will be complete from effluent to final treated water discharge.
- 2- By operating the plant, tenderer has to keep the parameters like BOD, COD, TSS, oil & grease, pH etc. well within the limits prescribed by the **Rajasthan State Pollution Control Board, Jaipur**. Treated water will be drained only to a agriculture/gardening area of SGZDUSS.
- 3- Persons engaged by tenderer will have to monitor the treated water parameters and have to record the same on hourly basis.
- 4- The Tenderer will get consent from RSPCB for our effluent treatment plant at Hanumangarh dairy, Milk chilling center Suratgarh, Nohar, Padampur & Gharsana as per requirement of RSPCB.
- 5- Raw and Treated effluent sample to be taken as per schedule of testing i.e. quarterly by tenderer and collect the testing report from RSPCB lab / lab recognized by RSPCB & have to submit with monthly bill. Testing charge if any will be borne by tenderer.
- 6- The tenderer has to perform all the preventive & breakdown maintenance and has to keep the plant in operation without stop. He has to deploy trained maintenance person for above purpose.
- 7- Records for preventive & breakdown maintenance will be maintained by tenderer / tenderer representatives / operators. SGZDUSS shall have the right from time to time to demand any original record and / or photo state copies of such record either for inspection and / or for retention for any duration.
- 8- Consumables, spare parts including motor rewinding shall be provided by SGZDUSS.
- 9- Cleaning of drying beds shall be carried out by the tenderer as and when required & dried sludge to be disposed in gardens maintained at SGZDUSS.
- 10- Tenderer has to follow the procedures laid down under ISO & HACCP system and has to work to maintain the ISO, HACCP, RSPCB & CPCB Norms.
- 11- The tenderer / consultant has to bring the results without any modification in the ETP & have to maintain R.S.P.C.B. norms.
- 12- The tenderer has to pursue the consent application under air & water act submitted to RSPCB and will get the consent from RSPCB and will submit the same to the M.D, SGZDUSS, Hanumangarh as per requirement. However necessary fees of RSPCB, consultancy/consultant fees for consent will be paid by the Milk Union, on production of receipt. If any extra expenditure required it will be borne by the tenderer. In case of consent failure under the air & water Act, the tenderer will be responsible to pay the consent fee or any other penalty imposed by RSPCB.
- 13- The tenderer has to distribute the treated water in various areas with in the dairy premises as required through the system provided and has to maintain it.

- 14- The tenderer has to maintain Housekeeping, cleaning and hygiene condition around the ETP as per ISO & HACCP requirements including cleaning of drying beds.
- 15- The tenderer has to develop and maintain the garden around ETP by developing & maintaining lawns in surrounding area. Plants of various kinds of flowers, shadowy plants and fruit giving plants as per requirement. The material for above purpose shall be provided by SGZDUSS.
- 16- Tenderer has to provide operators to run the plant in all three shift and one person to maintain the good hygiene near ETP. He has to provide one operator at milk chilling center Nohar, Padampur, Suratgarh, and Gharsana for operation & maintenance.
- 17- Tenderer or his qualified representative has to visit Hanumangarh Dairy whenever required.
- 18- The contract would be valid for two year. Managing Director, SGZDUSS at its sole discretion can extend the contract for next six months and with mutual consent of the tenderer it can be extended for another six months on same terms & conditions of the agreement. This contract can be terminated by Managing Director, SGZDUSS at any time by giving 15 days notice.
- 19- The Tenderer/ Firm will raise the bill in duplicate during the first week of every month to the section Incharge for its processing and payments.
- 20- The tenderer would ensure that the quality of finally treated effluent will be within the limits as prescribed by the RSPCB and other statutory authorities.
- 21- The tenderer shall maintain and operate the ETP for 24 hours a day and on all days of the year so that the treated effluent confirming to the prescribed standards of RSPCB will be discharged from the ETP. The SGZDUSS will have to fulfill only the official formalities required under law. The efficiency and regular operation of the ETP through out the year to enable obtaining the Consent from the RSPCB and other condition of Govt. will be tenderers responsibility.
- 22- Tenderer will have to ensure smooth & efficient operation and maintenance of the plant. In case of plant breakdown or failure, tenderer will ensure proper technical inputs for speedy resumption.
- 23- All the persons deployed by tenderer will exclusively work under tenderer's supervision & control. These persons shall be exclusively tenderer's employees.
- 24- Tenderer have to obtain license under the Contract Labour (Regulation & Abolition) Act 1970.
- 25- Tenderer shall be solely responsible for any claim, damage, compensation etc. that may become payable to any of the person (s) deployed by tenderer in any disability, injury or death of the person of tenderer's in connection with or concerning the said work within or outside the premises of the SGZDUSS. SGZDUSS shall not liable in any manner whatsoever either monetarily or other wise for any accident or mishap as mentioned above.
- 26- In case SGZDUSS suffers any losses or damage on account of any negligence or default on the part of person(s) deployed by tenderer. Then tenderer shall be liable for such loss or damage and shall further keep the SGZDUSS fully indemnified against any such loss or damage. The cost of make good the loss or damage shall be ascertained by SGZDUSS and it will be recoverable from

tenderer's dues, bills and securities extra and the decision of SGZDUSS shall be final on tenderer in this behalf.

- 27- Tenderer shall have to comply with all statutory and administrative requirements in connection with (i) personal so deployed by tenderer in connection to the said work (ii) their commercial arrangement.
