

1.0 SCOPE OF WORK:-

The consultants shall provide services in respect of the following works:-

- 1.1 Business plan of the Milk Union
- 1.2 Detail Project report (Financial) showing increase in income, BEP, Debt Service Coverage Ratio (DSCR), Cash flow and fund flow statement.
- 1.3 Pay back period of the investment (based of cost sheet)
- 1.4 Loan amount and EMI
- 1.5 Time period of repayment of loan
- 1.6 Technical presentation on behalf of SGNR ZDUSS LTD at any level of project, if required.
- 1.7 Final report submission in five copy

2.0 CONDITIONS FOR ENGAGEMENT:

- 2.1 The Consultants shall submit to the employer the conceptual design, report, drawings, documents etc. within the period mutually agreed and to attend the meeting for finalization of the same as and when called at the venue fixed by SGNR ZDUSS LTD. Cost of travel, boarding and lodging of the consultant shall be borne by the SGNR ZDUSS LTD (For maximum 3 visit, maximum 2 person).
- 2.2 The Consultants shall exercise all reasonable skill, care and diligence in the discharge of duties hereby covenanted to be performed by them.
- 2.3 The Consultants shall not make any deviation, alteration, omission from the approved design without the written consent of the employee. The Consultants shall also not issue drawings or instructions which shall lead to extra items or work without prior consent of the SGNR ZDUSS LTD.
- 2.4 The Consultants shall on the completion of the work supply to the SGNR ZDUSS LTD free of cost five complete sets of Final report. The Consultants shall, if so required by the SGNR ZDUSS LTD, will supply extra copies of all such drawing at an additional cost (cost at actual.)
- 2.5 The Consultants shall provide three sets of all the drawings & details photographs of model & model itself, perspectives drawings to appropriate scales as may be required by the SGNR ZDUSS LTD, if any/required.

3.0 TERMINATION OF MOU (Agreement):

- 3.1 The MOU herein may be terminated at a time by SGNR ZDUSS LTD by giving a written notice of one month to the consultant. Even after the termination of their employment, the consultant shall remain liable and responsible for the drawings and designs in respect of the work executed before the termination of the Agreement (MOU) but in so far as the original design as proposed by the Consultants is retained and executed to its logical completion. The Consultant shall have no liability for the Architectural design if changes are made and affected after termination of the Consultants Contract.
- 3.2 If the Consultants shall close the business or die or become incapacitated from acting as such Consultants, then the MOU shall stand terminated.
- 3.3 If the Consultants fails to adhere to the time schedule stipulated in the schedule hereto annexed of the extended time which may be granted by the Employer in its sole discretion or
(ii) In case there is any change in the constitution of the firm of the consultants for any reason whatsoever, the SGNR ZDUSS LTD shall be entitled to terminate this MOU and entrust the work to some other Consultants.

In case of termination under any one or more of the sub-clauses (3.1) (3.2) or

(3.3), the Consultants shall not be entitled to any fees or compensation except the fee payable to them for the stage of work actually done by them in accordance with Clause 6 hereunder. In such cases, the work actually done and the amount of the fee due to the Consultants shall be worked out jointly by the Employer and the Consultants on the basis of actual work done and mutually agreed between both parties and shall be final and binding on both parties.

In case of the termination under anyone/more sub clause (3.1), (3.2) or (3.3) the SGNR ZDUSS LTD may take use of all or any drawings, estimates or other documents prepared by the Consultants, after payment for the services of the Consultants for preparation of the same in full as provide herein and after the written consent of the Consultants.

4.0 TRANSFER OF INTERESTS:

Neither the SGNR ZDUSS LTD nor the Consultants shall assign sub-let or transfer their interest in this MOU without the written consent of the each other.

5.0 PROFESSIONAL FEES:

5.1 The Consultants agree to provide the services referred to above and in consideration thereof, the SGNR ZDUSS LTD agrees to pay remuneration provided in financial proposal.

5.2 All other taxes, levies shall be extra of the fee mentioned in financial proposal by consultant

5.3 Service Tax/GST or applicable as levied by Govt, will be payable as per statutory law on our gross bill. Any additional alterations to such tax laws during and after commencing of work; If imposed by Government will also be payable by the consultants additionally. These will be over & above the total fees payable.

6.0 THE SGNR ZDUSS LTD RESPONSIBILITY:

The SGNR ZDUSS LTD agrees to perform the following duties with a view to facilitate the Consultants to do their professional work efficiently and effectively.

6.1 Furnish design brief and other requirements of the projects.

6.2 Provide site plan to suitable scale showing boundaries, existing roads and proposed paths, existing services & utility lines and such other lines to which the proposed services can be connected.

6.3 Furnish existing Plant data required for project.

6.4 Pay the fees to the consultants within one month of submission of bills.

7.0 MODE OF PAYMENTS:

For the services in the scope of work the Consultants shall be paid in the following stages consistent with the work done plus reimbursable expenses as agreed upon. Payments made to the Consultants are on account and shall be adjusted against the final amount payable.

Stage-I Advance payment after release of work order. 80% of the total fees payable.

Stage-II On submission of final report submission 20 % of the Total fees payable

8.0 EFFECTING PAYMENT TO THE CONSULTANTS:
